Lyons provided the financial report ending February 28, 2023. Ewert added that from our short-term savings account, we had to withdrawal \$40,000.00 at the end of March. Our remaining balance is \$145,000.00.

**MOTION** made to approve the financial report ending February 28, 2023, with a YTD net income (loss) of (\$215,841.00) and seconded (Jonson/Decuir) motion carried

Ewert provided an update on Board Membership – Have asked three (3) people supported, the time is challenging. BOD Members know of anyone who would like to be a member, email Celeste. Shaddock suggested that United Way 211 has a list of people interested in volunteering.

Executive Finance Committee for next FY: In May the Slate of Officers, vote in June, and start in July

Shaddock and Kramer provided an update for the Fund Development and Communications Committee (FDCC) –

- 2. Discussed our vision
- 3. Kramer is working on strategic plan for next FY
- 4. Focus on Early Intervention
- 5. Figure out programs that make the most sense, Early Intervention, Residential, etc.., to meet goals

- 8. 5K Communications, send out color brochure

McWilliams asked about the 5K Business Sponsorships. Ewert will send an email with the full packet that includes brochures. Kramer extended the deadline for sponsorships to the end of month.

Ewert updates on Conflict Free Case Management (CFCM) and Case Management Redesign (CMRD) – The RFP is closed. Not a lot is going on at the State or Local level. BOD Members (Pam, Meghan, Tommi and Erica) hosted "Coffee Talks" with Case Management. Answering questions and hearing their concerns. On April 24th there will be a Question-and-Answer session with Area Agency on Aging at Envision. Health Care Policy and Financing (HCPF) will be getting back to us next week to let us know if we will be getting any additional funding.

Ewert provided information from monthly report with State and Local updates. (See report) Ewert added that we received an additional \$267,000.00 of State General Funds to help with over utilization in the State Supported Living Services, and the Family Support Services Program. \$32,000 will be used to pay for staff for the Summer Respite Program.
